## 4. WINNING/ODDS:

**Location Drawings:** On or about February 11, 2022, there will be fifty-eight (58) random drawings. Entrants will be eligible for one of the drawings based on the Metro Diner® location the Entrant selected or purchased at the time of entry. There will be a total of thirty (30) prize winners selected per Metro Diner® location in a random drawing from among all eligible entries received during the Sweepstakes Period for each Metro Diner® location. **Grand Prize Drawing:** There will be one (1) random drawing held on or about February 11, 2022 to select ten (10) grand prize winners (each a "Grand Prize Winner") from among all eligible entries received during the Sweepstakes Period. Odds of winning a grand prize ("Grand Prize") will depend upon the total number of eligible entries received during the Sweepstakes Period across all Metro Diner® locations.

UNDER NO CIRCUMSTANCES SHALL SPONSOR BE RESPONSIBLE OR LIABLE FOR ANY CONSEQUENTIAL DAMAGES. THERE ARE NO OTHER REPRESENTATIONS OR STATEMENTS REGARDING THE VEHICLE, AND THERE ARE NO IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION, NO WARRANTY OF FITNESS FOR ANY PARTICULAR PURPOSE OR USE NOR ANY WARRANTY OF MERCHANTABILITY. Grand Prize is taxable as income and all taxes associated with the Grand Prize are the sole responsibility of Grand Prize Winner.

**Local Prizes:** A total of thirty (30) prize winners at each Metro Diner® location will receive \$500 worth of Metro Diner® gift cards to be used at any Metro Diner® location (each a "Local Prize").
